47	Mr. Gibbs stated that the minutes of the November 6, 2024 meeting were in the	
48	packet and asked for a motion	n to approve the minutes of the meeting, if there were no

1	corrections. Mr. Jeane moved, seconded by Mrs. Cupit to approve the circulated
2	minutes of the Board meeting of November 6, 2024. Motion carried unanimously.
3	STAFF REPORTS: Item #1-TBPJO- Power House Operations: Mr. Founds
4	stated that year-to-date thru November 11th, run hours were Unit #1-4,471 hrs. and Unit
5	#2-4,685 hrs. He stated that total generation year-to-date thru October 27th was 342,809
6	MWH. He stated to update everyone on the Power House Step-Up Transformer
7	Replacement Project that the Power House has been in outage since September 16 <sup>th</sup> . He
8	stated that it was energized on November 19th. He stated that the transformers have to
9	warmup before performing test runs. He stated that the guide calls for attempting to
10	maintain a level of 168'MSL. Emergency Spillway Generator: He stated that the new
11	generator, transfer switch and fuel tank are in place He continued that the completion
12	date is scheduled for December 6, 2024. He stated that testing and commissioning is
13	scheduled to be performed by Loftin Equipment on December 2 <sup>nd</sup> . Reservoir
14	Levels/Status: He stated that the average reservoir level for as for October was
15	167.58'MSL, and thru to November 28th was 167.65'MSL. RELEASES: He stated that
16	during October the total releases through the Power House and the Spillway was 127,400
17	AC FT, and up to November 19th total releases have been 7,322,036 AC FT.
18	FERC/NERC/SERC: He stated that Certrec Corporation continues to provide support
19	to SRA-TX and SRA-LA for NERC/SERC/FERC compliance issues for Power House.
20	He stated that the annual FERC inspection took place on July 31st. He stated that staff
21	has received notification that the assessment has been scheduled for November 18th and
22	December 2 <sup>nd</sup> for the 11 <sup>th</sup> Part 12D-Comprehensive Assessment was schedule for
23	November 18 thru December 2 <sup>nd</sup> . He stated that P12D Inspection and PFMA began on
24	November 18 <sup>th</sup> . He stated that a inspection by FERC and HDR was done with the SRA
25	Crew installing the stop logs in Gate #7 and performing a full opening of the gate. He
26	stated this was followed by brainstorming PFMs and discussion on each one.
27	Item #2-Shoreline: Permitting Activity: Mr. Strother stated that there were (9)
28	new structure permits, (10) transferred structure permits, (1) new water withdrawal(s), (2)
29	transferred water withdrawals, (0) cancelled water withdrawal, (2) shoreline
30	improvement (erosion control/dredge), (3) approved final inspections and (0) failed final
2 1	inspection NORTH-Converse area: Onesw structures: O transferred structures: O

OTHER: He 10 11 stated that no report. 12 Item #3-Operational: TOLEDO BEND: Mr. Remedies stated that the revetment mats are scheduled to be delivered Tuesday, December 10th. He stated that the 13 repair of the 14th Green Seawall at the Golf Course is now completed. He stated that Joey 14 15 Cartinez and crew have been clearing underbrush at Site 7A-San Miguel and have been 16 cleaning and filling in low areas for parking at Blue Lake boat ramp. He stated that the 17 maintenance crew had been putting up the Christmas lights and decorations getting 18 Cypress Bend Park ready for the holiday season. SRD: He stated that the Capital Project #15-Meter Upgrade had some issues with being allowed access to the plants that are 19 20 serviced by the diversion canal has moved forward. He stated that Randy Brewer and crew have finished the second round of mowing the levee system as well as repaired two 21 22 leaks in the levee system- one bad irrigation gate and the other a small seepage. He 23 stated that the crew also installed all the culverts on the intake canal levee. He stated that 24 Project #7-Upgrade of the SCADA System is installed and John from the Toledo Bend 25 Office has been working the representative with Sycon to transfer data. 26 Financial Report: Mrs. Ferguson stated that so far the Christmas Lights 27 Visitation has seen approximately 1,700 people which arrived in 415 cars paying the \$10 28 fee which is a total of \$4,150.00. She reminded the Board members that the displays would shine brightly until December 29th every Thursday through Sunday with Santa 29 30 Claus visiting the park on Fridays and Saturdays. She stated that the office would be closed for the Christmas holiday December 24th though the 26th and for the New Year's 31

- 1 holiday December 31st and January 1st. She stated that for the Diversion Canal Division
- 2 totals for October showed revenues of \$719,382.10, expenses of \$288,305.68 leaving a
- 3 profit of \$431,076.42. She stated that the Toledo Bend Division revenues were
- 4 \$305,340.40, expenses were \$545,081.51 showing a loss of \$239,741.11. Mr.
- 5 Goodeaux moved, seconded by Mr. Jeane to approve staff reports as circulated and
- 6 presented. Motion carried unanimously.
- 7 SPECIAL REPORTS: None.

- 9 OLD BUSINESS: Item #1-Review Handout of Proposed By-law changes for
- 10 **January Vote:** Tabled until January 2025 meeting.
- 11 NEW BUSINESS: Item #1-Discuss Purchase Surge Protection Equipment
- 12 for Pump Station #4 & Item #2-Emergency Repair of By-pass Pump at Pump
- 13 Station #4: Mr. Remedies stated that staff is requesting to purchase the necessary surge
- 14 protection equipment for the system at Pump Station #4 from the Major Repair Budget
- 15 item "Repair Levee from erosion, animal dens, seepages and leaks". He stated that there
- have been several lighting strikes at this location and with the installation of the new
- diesel pumps, it would protect the equipment preventing any down time. He stated that
- 18 the cost of the equipment \$20,911.00. He stated that he would like to discuss a sensor the
- 19 needs to replace at Pump Station #3 and #4. He stated that the sensor in question gives
- 20 heat/cool data and they are not in working order at this time. He stated that the screens
- 21 would also be replaced/repair at the same time. He stated that the total cost of this item is
- \$19,020.00 for these repairs. He stated that the total cost of the two items would be
- \$39,931.00. Mr. Goodeaux moved, seconded by Mr. Vidrine to approve the
- 24 purchase of surge protection equipment for Pump Station #4 and to approve the
- 25 repair of the sensors for Pump Station #3 and #4 with both items costing \$39,931.00
- 26 to be paid from Major Repairs item "Repair levee from erosion, animal dens,
- 27 seepages and leaks". Motion carried unanimously.
